Address: Greywell, High Street, Bursledon, Southampton, SO31 8DL

Description: Construction of garage with ancillary first floor accommodation, rebuilding of brick boundary wall and new internal courtyard wall.

RESOLVED: Refer the Local area Committee due to concerns regarding the size of the garage development exceeding the 25% permissible in the conservation area and concerns regarding the potential for commercial use or separate living accommodation. Due to the protection orders on the trees and the sensitive historical value of the wall a cross authority meeting was recommended to find a solution that protects both the trees and the wall.
